 an international cross - border gastronomic fair for the promotion of typical products and catering/hospitality industry in the Adriatic Area



# FIRST LEVEL CONTROL

-Control of the project costs, which will be done at Final Beneficiary level

- Each state has appointed a central body to carry out the First level control (Croatia, Italy, Bosnia Herzegovina) *REPORTING* 

-Each Final Beneficiary produces regular Progress Reports on its expenditure and submits it with all mandatory annexes to the respective National FLC Officer (FLCO)

-FLCO cheks the elegibility of the costs and fills in a Declaration on validation of expenditures (DVE). FLC has 3 months to conduct the First Level Control of the project costs.
